### WANT TO BECOME A TCL DUAL ENROLLMENT STUDENT? START WITH OUR ADMISSIONS PROCESS!

Students must apply online, gain approval from their high school counselors, and submit required enrollment documents to start the dual enrollment process. Enrollment documents must be submitted either directly from a school counselor or via email from TCL student email accounts.

school counselor or via email from TCL student email accounts.
1. Apply online at <a href="https://www.tcl.edu/apply">www.tcl.edu/apply</a> as a Dual Enrollment student. There is no fee to apply to Technical College of the Lowcountry.
Click Apply Now, then Create Your Account and verify your email address.
Select Admit Status - "Dual Enrollment High School Student."
Enter your high school and expected graduation date. Under Program Choice, click "Other," then select first term you plan to attend. For Campus Location, choose the campus closest to your high school.
Review the Image Release, Financial Liability, and Student Statements, click "I Agree" for each, then select "Submit" to finish your application.
2. Meet with your school counselor, then submit Dual Enrollment Agreement/FAFSA Waiver, Residency Verification, and FERPA Waiver forms.
Beaufort County School District, Colleton County School District, Hampton County School District, and Jasper County School District students must obtain their enrollment paperwork directly from their school counselors. These packets must be submitted to their school counselors for approval and signatures.
Private, charter, and homeschool students must complete the Dual Enrollment Agreement/FAFSA Waiver and Residency Verification forms, then submit to your school counselor/homeschool association staff member for administrative approval and signatures.  Forms – Visit <a href="https://www.tcl.edu/ecco-college-credit/">www.tcl.edu/ecco-college-credit/</a> , then select your county/school type to access required forms.

## What Are My Options?

#### **Dual Enrollment Opportunities for High School Students**

High school students who have mastered the high school curriculum and are ready for college-level work may participate in the following dual enrollment opportunities at Technical College of the Lowcountry.

#### **University Transfer Track**

General Education/University Transfer courses are designed for students planning to attend a 4-year college or university or desiring to get a head start on general education courses required in 2-year programs at TCL. Taking one or more of these courses while in high school can save time and money and enable students to experience college-level coursework while refining interests in specialized fields. To prepare, students should complete the following:

- Review courses required for their intended college major at TCL or other 4-year college or university in order to select the most appropriate courses;
- Check with the college they plan to attend to verify course transferability and the grade that must be earned;
- For more information about these options, see page 13.

#### **Career and Technical Education (CTE) Track**

Career and Technical Education programs are designed for students planning to enter careers in various areas of industry with critical workforce needs. Completion of these pathways offers students rapid entry into the workforce, and credits can be applied toward a Technical College of the Lowcountry certificate, diploma and/or Associate in Applied Science degree in the same field. Dual Enrollment students can complete their certificate or diploma at TCL prior to graduating high school as well as finish their Associate degree within one year of high school graduation. By completing a CTE program, students may enter the workforce with higher entry salaries than their peers with four-year degrees! Career and Technical Education programs for high school students include the following programs:

- Accounting
- Building & Construction
- Business Management & Administration
- Computer and Information Technology
- Culinary Arts
- Early Care and Education
- Entrepreneurship/Small Business
- Heating, Ventilation & Air Conditioning
- · Law & Criminal Justice
- Plumbing

## Dual Enrollment – FAQ

#### Who is eligible to participate in TCL's Dual Enrollment Program?

Students enrolled in public, private, or approved home-schooled programs that are in high school, have completed English 1 and Algebra 2, and maintain a 3.0 GPA for all high school coursework are eligible to participate in TCL's Transfer Track. Students who maintain a 2.5 GPA for high school coursework are eligible to participate in our Career and Technical Education (CTE) track. See page 6 for more information.

#### How much does it cost take a Dual Enrollment course?

High school students participating in Dual Enrollment are responsible for all current tuition, fees, textbooks, and course materials unless otherwise negotiated between the College and the local high school district. Fees resulting from schedule changes are also the responsibility of the student. Dual Enrollment students may qualify for financial support through the South Carolina Education Lottery Tuition Assistance Program (LTA) to offset a portion of the costs. To be eligible for LTA, students must meet the following criteria:

- 1. Be a US citizen or legal permanent resident (must present alien registration card at time of application)
- 2. Be a South Carolina resident for a minimum of one year (12 consecutive months) or be a qualified active duty military member or dependent.
- 3. Complete a Dual Enrollment Agreement/Free Application for Federal Student Aid (FAFSA) Waiver form. This form indicates that the student is a Dual Enrollment participant and must be completed and approved prior to registration. Costs will be covered only if this form is processed prior to the start of classes.
- 4. Maintain a minimum 2.0 GPA (Grade Point Average) and follow the Student Code of Conduct thereby never being involved in administrative suspension and academic or student misconduct.

#### What kinds of courses can I take?

Any available course the High School approves may be taken on any of the TCL campuses: Beaufort, New River, Culinary Institute of the South, and Hampton.

- Arts and Sciences transfer classes in English, humanities, mathematics, language, physical sciences and social sciences.
- Career Development and Technology courses: Business (Accounting, Entrepreneurship/Small Business, Medical Office Assistant) Pre-Health Sciences; Industrial Technology (Building Construction, HVAC, Plumbing); STEM (Computer and Information Technology); Criminal Justice and Law (Criminal Justice)

Successful completion means earning a grade of A, B, or C. All grades are posted on the student's official record at the completion of the course. #### How do students earn both high school and college credit for the same course?

Prior to beginning a course, it is the student's responsibility to communicate with the high school regarding earning high school credit for college courses (only the high school has the authority to grant high school credit for college courses). TCL awards college credits for successfully completed college courses.

#### Where can I view available classes?

Students can use TCL's course search tool to view course offerings each semester. Visit <a href="www.tcl.edu/course-search">www.tcl.edu/course-search</a> to obtain a full list of our available classes.

#### How do I register for classes?

Once you have submitted your TCL application, met with your high school counselor to confirm you've met the eligibility requirements, and submitted your Dual Enrollment Agreement and Residency Verification forms to your school counselor, please attend your school's Registration Day event. If you are unable to attend the event, work with your counselor to submit your course request to Sara Cain, the Dual Enrollment & Early College Coordinator, at <a href="mailto:dualenrollment@tcl.edu">dualenrollment@tcl.edu</a>.

- If you are a homeschool student, email your course request to dualenrollment@tcl.edu.
- Dual Enrollment students are NOT allowed to register themselves.

#### How can I view my class schedule?

You can view your schedule by logging into your Navigate or Self Service account. Visit the Quick Links menu at tcl.edu to access either account.

If you are a home school student, you can contact Sara Cain, the Dual Enrollment & Early College Coordinator, at <a href="mailto:dualenrollment@tcl.edu">dualenrollment@tcl.edu</a> to obtain a copy of your schedule.

#### How do I know where my classes are?

When you look at your class schedule, each class will have a building number and room number next to it, as well as days and times that it meets. For a campus map: https://www.tcl.edu/campuses-maps.

#### Who will the instructor be?

All instructors teaching TCL courses are approved full time or adjunct instructors of the College. If you are taking a course on a high school campus, the instructor may be a teacher from your school. However, that instructor meets the same requirements as if he/she were teaching at one of the TCL campuses.

#### Where can I order my books?

You will reserve your textbooks through the TCL Course Ready program.

After registering for courses, you will receive an email to your TCL student email account within 2-4 weeks that prompts you to reserve your books. You can choose to have ebooks (available in Blackboard), have books shipped to you for a small fee, or pick up your books at the TCL College Store in Bldg. 12. Visit page 10 to learn more information about reserving textbooks through TCL Course Ready.

## Dual Enrollment – FAQ

#### What is the attendance policy?

TCL expects that students will participate in all scheduled instructional classes and laboratory periods, regardless of the mode of delivery. To be successful in their courses, students are expected to be in class on time and to attend class meetings or laboratory periods regularly. Students are responsible for making up the work missed during any absence. An absence is defined as nonattendance for any reason, including illness, emergency, or official leave. If you arrive late to or leave early from class, you may be considered absent for that class.

#### Does a certain grade have to be earned?

Yes, to be successful in a TCL course means that you must earn a grade of A, B, or C. If you receive a D in a course, you will receive a passing grade which will be reflected on both your TCL and high school transcript, but D grades are NOT TRANSFERABLE to other colleges. If you receive an F in a course, you will not receive credit for the course at either TCL or your high school.

<u>Note</u>: Students who transfer to any college or university in South Carolina and who plan to take advantage of the LIFE Scholarship must maintain a 3.0 GPA for all college level coursework.

#### Where can I find my grades?

Students may check their academic progress in courses on Blackboard as percentages; however, official grades are only found in Self Service and Navigate. The final grades posted in Self Service and Navigate are letter grades. TCL awards both a letter and numeric grade to dual enrollment students taking college courses; however, only the letter grade will be visible on the official college transcript.

#### Can anyone else see my grades?

Final grades are released to high school counselors and administrators. If students want their records released to another party (e.g. a parent or guardian), students must complete a FERPA (Information Release) waiver form. Privacy of student educational records is regulated by the federal Family Educational Right to Privacy Act (FERPA). Visit page 18 to learn more information about the FERPA waiver form.

#### **How do I order an official transcript?**

Once you graduate from high school and continue your higher education at a university, you will need to request an Official TCL college transcript be sent to your designated university of choice. TCL uses Parchment to send transcripts. Order your transcript at <a href="https://www.tcl.edu/student-services/student-records/transcripts/">https://www.tcl.edu/student-services/student-records/transcripts/</a>.

#### Do all college courses transfer to four-year colleges or universities?

TCL participates in a statewide articulation agreement that lists 86 specific courses that are guaranteed to transfer to the state's publicly supported colleges and universities. Career Development and Technology courses may be transferable to a related program of study. It is the decision of the receiving college or university to approve the transfer of credit. #### Am I eligible for any financial aid?

High school students who take six or more credit hours in one semester may qualify for the South Carolina Lottery Tuition Assistance Program. Students enrolled in certain Career and Technical Education programs (e.g. Culinary or HVAC pathways) may be eligible to receive SC WINS funding.

#### Does dual enrollment impact future financial aid eligibility?

When students take college courses in high school, they begin a college transcript, including a college GPA and completion rate. All TCL grades are included on the college transcript and factored in determining federal/state financial aid eligibility after high school graduation at Technical College of the Lowcountry. The Federal Financial Aid requirement of Satisfactory Academic Progress, or SAP (2.0 GPA, 67% completion rate, and maximum 150% program-required credit hours), is assessed at the end of each semester.

Students need to understand that performance in dual enrollment courses can help or hurt their ability to receive financial aid (grants, scholarships, and loans) once they are a regular college student after high school graduation.

#### How do I pay my bill?

Students attending any public schools in Beaufort, Hampton, Jasper, or Colleton County school districts will not need to pay for courses. Students attending private, charter, or homeschools will need to access the Student Finance tab in Self Service in order to pay their bill each semester. Balances can be paid in full or paid via payment plan.

## DUAL ENROLLMENT ELIGIBILITY REQUIREMENTS

#### **University Transfer Track**

Students who plan to enroll in the University Transfer track must meet the following criteria:

- Students must hold a 3.0 GPA.
- English 1 must be completed with a B average or higher.
  - Students currently taking English 1 must provide a grade report reflecting a grade of B or above.
- Algebra 2 must be completed with a B average or higher.

\*NOTE: Beaufort County School District freshmen students must meet the 93 percentile PSAT requirement in order to participate per district guidelines.

#### Career and Technical Education (CTE) Track

Students who plan to enroll in the Career and Technical Education (CTE) track must hold a **2.5 GPA**.

### If students do not meet the eligibility criteria for their preferred Dual Enrollment track, they must complete the following steps:

- 1. Meet with their school counselor and determine if Dual Enrollment is a possibility.
- 2. After obtaining school counselor approval, students must do one of the following:
  - Provide a Letter of Recommendation from a current or former teacher

OR

Complete the Accuplacer Placement Test (see page 8 for more information)

# Getting Started - Student Accounts & Orientation

#### YOUR TCL ACCOUNT PROCESS

After you submit your online Dual Enrollment Student application to Technical College of the Lowcountry, you will receive an acceptance email within 48-72 business hours. This initial contact is followed by a second email, which contains your admissions steps and instructions for setting up your TCL student email account.

#### USING YOUR NAVIGATE ACCOUNT

Navigate is TCL's hub for viewing your schedule, connecting with your Dual Enrollment representative, and scheduling appointments with TCL staff members. The Navigate App will be used by all students to schedule appointments with Admissions, Dual Enrollment staff, Tutoring services, and other support services. This will also be used to communicate with students about the onboarding process, class registration, grades, early alerts, and campus event announcements.

#### USING YOUR SELF SERVICE ACCOUNT

Self Service is TCL's online portal for students to access their personal account and academic information. Tabs are provided to help you find the information you need. Within each tab, you can view tuition, financial aid, course, and grade information. #### **DUAL ENROLLMENT ORIENTATION**

#### IN-PERSON/ZOOM ORIENTATION SESSIONS

New Dual Enrollment students at Technical College of the Lowcountry are required to attend either an in-person or Zoom orientation prior to the start of their first semester. Students are permitted to bring a guest to orientation.

#### **BLACKBOARD ORIENTATION COURSE**

In addition to attending a formal orientation session, Dual Enrollment students are required to complete the Blackboard Orientation course. This course is available in all students' Blackboard accounts and must be completed prior to the start of their first semester. The course will teach students how to navigate the Blackboard system, submit assignments, utilize ebooks and access codes, and more! - ✓ Placement testing is free to all students.
- ✓ Students may choose to retest in subject area(s) in which they did not receive a qualifying score.
- ✓ Allow approximately 2 2 ½ hours for all three subject areas (45 minutes per subject test). Tests are untimed.

### Paying for Courses

#### BELOW ARE THE CURRENT ACADEMIC YEAR TUITION RATES.

The 2024-2025 rate is \$222 per credit hour for students holding <u>in-state residency</u>. Tuition for one 3-credit hour course is \$666, plus required fees and textbook costs\*. Students who meet in-state residency requirements may qualify for TCL's Dual Enrollment Fee Waiver. Students who meet residency requirements and enroll in six or more credit hours (typically two courses) in the same semester may qualify for Lottery Tuition Assistance. If you qualify, the chart below shows the portion of your tuition costs per semester that Lottery Tuition Assistance and Dual Enrollment Fee Waiver will cover.

Some courses require additional fees (e.g. advanced computer technology or lab science courses), so fee amounts may vary.

Most university transfer courses are 3 credit hours; foreign language, lab science, or Calculus courses are typically 4 credit hours.

Students holding out-of-state residency will receive the current non-resident tuition rate of \$462 per credit. Please contact the Dual Enrollment and Early College Coordinator at dualenrollment@tcl.edu to learn more about residency.

#### Paying Tuition and Fees - Homeschool, Private School, and Charter School\*\* Students Only

- ✓ Students must pay the balance of tuition and fees or set up a payment plan by the posted deadline each semester.
- ✓ Payments may be made online from the Student Finance tab in Self Service or in person at the Beaufort or New River campuses.

# Dual Enrollment Financial Aid Information

#### **South Carolina Lottery Tuition Assistance\***

- ✓ Dual Enrollment students enrolled in 6 or more credit hours (typically two courses) in the same semester may qualify for the South Carolina Lottery Tuition Assistance Program.
- ✓ Students qualify based on state residency requirements, not financial need.
- ✓ Contact <u>dualenrollment@tcl.edu</u> for more information about Lottery Tuition Assistance.

#### \* Lottery Tuition Assistance (LTA) Information

- State funded program awarded to South Carolina residents students must hold in-state residency status in order to qualify
- Applies to cost of tuition only
- Must be enrolled in at least 6 credit hours per semester
- Does not cover Continuing Education classes or non-credit classes
- Award amount varies annually
- High School students do not need to complete the FAFSA

#### Federal Financial Aid

Dual enrollment students do not receive federal financial aid because they have not completed high school. However, success in dual enrollment courses may impact a student's eligibility to receive federal aid and other scholarships upon entry into college after high school. Students should strive to make at least a C or higher in college courses and complete all courses started at a 67% completion rate. A GPA below 2.0 and a completion rate of less than 67% may impact a student's ability to qualify for federal aid after high school graduation. **Contact the Dual Enrollment Office at dualenrollment@tcl.edu** for more information.

# Textbooks & Other Materials

Dual Enrollment students reserve their textbooks through Technical College of the Lowcountry's Course Ready program. Textbooks are included in students' total tuition balance each semester, so required textbooks are not purchased separately.

#### TCL's Course Ready Program

- After registering for class, you will receive an email in your TCL student email account from TCL Course Ready. This email is typically sent about 3-4 weeks before the start of each new semester.
- Open the email, click Reserve My Books, then complete the ordering process. You can choose to pick up your textbooks at TCL's College Store (Beaufort campus, Bldg. 12), receive ebooks loaded directly into your Blackboard account, or have your textbooks shipped to your home for a small fee.
- Required textbooks will never request/require a payment, unless you choose to have your textbooks mailed to your home.
   TCL Course Ready will occasionally display optional materials for courses; any optional materials that students choose to purchase must be paid for out-of-pocket.
- After reserving your textbooks, you will receive an email 2-4 weeks later (depending on when your order was placed)
  confirming that your textbooks are ready for pick up OR have been sent via mail. Digital textbooks will automatically
  appear in Blackboard on the first day of the semester.
- At the end of each semester, students are required to return their textbooks to TCL's College Store. Textbooks are typically due on the last day of final exams. You can visit the College Store to return your textbooks or visit your TCL Course Readyaccount to download and print your return shipping label. If you do not turn in your textbooks on time, you will incur latefees. Schools/districts paying for students' tuition and textbooks are not responsible for late fees; students must pay any late fees out-of-pocket.

#### Additional Materials - Lab Kits

Physical sciences courses require both a textbook and a lab kit. If you attend a school/district that is paying for you to attend TCL, your lab kit will be covered by your school/district. You will receive an email in your TCL student email account at the start of the semester notifying you to pick up your lab kit voucher from TCL's College Store. You are responsible for picking up your voucher and ordering your lab kit (kits take 5-7 business days to arrive by mail).

If you do not attend a school/district that will pay for your textbooks and other required materials, you are responsible for purchasing a lab kit voucher from TCL's College Store. Contact our College Store at (843) 525-8303 for assistance with your lab kit voucher.

#### Additional Materials - Baking & Pastry, Culinary, and Hospitality Supplies

Baking & Pastry, Culinary, and Hospitality courses require uniforms, knife sets, and textbooks. If you attend a school/district that is paying for you to attend TCL, your supplies will be covered by your school/district. You will receive an email in your TCL student email account at the start of the semester notifying you to pick up your supplies from TCL's College Store. You are responsible for picking up your supplies before classes begin.

If you do not attend a school/district that will pay for your required materials, you are responsible for purchasing your supplies from TCL's College Store. Contact our College Store at (843) 525-8303 for assistance with your supplies.

### Career and Major Exploration — Choosing Courses

Choosing the right dual enrollment courses depends on several factors: the student's intended college major, the college or university the student plans to attend, and the type of degree the student wants to achieve. Students who spend time exploring careers and comparing college and university programs will benefit from knowing program requirements and career expectations before they begin taking college courses.

#### **Career Exploration**

- Research to see if there is a need for the career you'd like, in a location you want to live, and at a salary you desire by exploring the U.S. Bureau of Labor Statistics Occupational Outlook Handbook.
- Technical College of the Lowcountry's Career Coach webpage provides students the opportunity to explore a variety of career paths. Through Career Coach, you can complete an assessment that determines the careers that best suit your interests/strengths, compare positions and salaries, and more! Visit https://www.tcl.edu/admissions/career-coach/ to access all Career Coach materials.
- Job shadow, volunteer or intern in fields that you think you may want to work. Real life experience is sometimes the best way to find out if a career field is right for you.

#### **Major Exploration**

- Compare degree programs, campus life, and other opportunities available at a variety of colleges and universities to make sure you choose a
  school that is right for you and your career goals. Even if a college has your favorite football team, it may not be the best place for pursuing your
  career field and major.
- Research the course requirements for your program of study by looking directly at the college or university website's degree program
  curriculum. Know what math you need and if you need a specific social science, foreign language, or other general education course
  requirement.

#### **Dual Enrollment Course Selection for Successful Transfer**

- Check websites or directly contact in-state colleges or universities that you wish to attend to find transfer equivalency agreements for TCL courses. You may also check transfer agreements at <a href="https://www.sctrac.org">www.sctrac.org</a>.
- If you plan to attend a private or out of state school, contact that college to see if it will accept transfer courses from TCL. Not all private or out-of-state colleges accept transfer courses from other institutions.
- Choose courses that will meet general education requirements and help you prepare for program requirements. Most colleges and universities require that students take general education courses in Communication/Literature, Humanities, Math, Science and Social Sciences.

#### Be in charge!

Take ownership of your college experience by spending some time researching and planning. You are the only one who knows what you want to become in your future. Use the tools to help you decide how to best reach your career goals, and you'll be equipped for success!

## Student Success Checklist

Once you are admitted as a student and registered for your classes, be sure to follow these steps for success:

#### ☐ ATTEND CLASS – Success begins with showing up!

✓ You must attend the first week of class or you may be administratively dropped for nonattendance. This includes online classes – you should log in the first day.

#### □ READ THE SYLLABUS COMPLETELY

✓ Your course syllabus contains essential information regarding due dates, course policies and expectations, and instructor's office hours. It is your responsibility to know and comprehend all information included in the syllabus.

#### ■ PREPARE AND PARTICIPATE

✓ Complete reading and other assignments before class so you are able to ask questions and participate in class discussions.

#### ☐ CHECK GRADES REGULARLY (especially midterm & final)

- ✓ In Blackboard, you should be able to track your progress from within each course by selecting My Grades. Blackboard does not provide official grades.
- ✓ In Self Service, click on the Grades tab to view final grades for past classes. This is where you obtain **official grades**.

#### ☐ COMMUNICATE WITH INSTRUCTORS

✓ Discuss concerns directly with your instructor right away. If your instructor is not available before or after class, make an appointment during office hours, by phone, or even an email chat. Please allow 24 hour professional window courtesy for an instructor response before a second contact is made.

#### ☐ SEEK TUTORING

✓ Successful students seek tutoring as soon as they realize they need additional explanation and support. Don't hesitate to seek assistance at the Tutoring Center for any of your TCL courses.

#### ☐ DROP AND WITHDRAWAL – Know the difference!

- ✓ Students may drop a course during the first week of the semester and it does not appear on the final college transcript, and tuition is removed/refunded (if the student paid out-of-pocket tuition costs) for that course it is like the student was never in the course. If you know you don't plan to finish a course, drop before the deadline.
- ✓ Withdrawing from a course must be done before the end of the withdrawal period, about two-thirds into the semester. A withdrawal appears on a student's college transcript as a W and may impact future financial aid. Students should speak to their instructor prior to withdrawing from a course. If an instructor suggests that there is not a way to pass a course, a W is a better alternative than a failing grade on a college transcript. See withdrawal instructions on the bottom of page 6.

#### Top 10 Supporting Role Tips for Parents and Other Persons of Support

Students who are most successful have a variety of people in their lives who are willing to provide assistance, support, guidance and advice. If you have a student in your life who is taking college courses, consider these Supporting Role Tips to help your student succeed:

- 1. Give your students the opportunity to be in charge of the college process.
- 2. Provide advice, support, guidance and reminders. Then step back and let students make choices.
- 3. Recognize the difference between assisting students and "taking over."
- 4. Encourage your students to make their own phone calls, write emails, or speak in person to people of authority, including college instructors. They need this practice!
- If there is a sign-in sheet, forms to complete, or online submissions to make, have your students complete them.
- Choose constructive encouragement and advice when you recognize your students need guidance or motivation to follow through or give more effort.
- Recognize that college staff are familiar with assisting young adults and teenagers. It is OK if students need to call back again and again before figuring out how to best ask their questions. This is part of learning.
- 8. Avoid taking over simply because you think you can do it faster or better.
- 9. Offer suggestions and support when your students are trying to solve problems.
- 10. Realize that soon your students will have no choice but to manage college (and life!) on their own, often hours away from you. It's a good thing and part of growing up!
- ✓ Students should discuss with their high school counselors to determine how a withdrawal will affect their high school transcript.
- Students who withdraw from a course will not receive a refund for the tuition and fees for that course.

#### ☐ CHECK EMAIL DAILY

✓ Students should check their TCL email account for important communications from instructors and the college. FERPA regulations prevent the college from sending information to other email addresses, but students may choose to forward their email to another email address.

# Student & Parent Communication

Communicating with an instructor that you are just getting to know may be a bit tricky. Here are some guidelines you may want to take into consideration when sending an email:

- Introduce yourself preferably from your TCL email account and explain which class you are taking with the instructor and on which campus.
- Express your concerns in a simple and straightforward capacity and end the e-mail with an action statement such as "Can I stay after class to discuss this with you?" or "Do you have a time that would be convenient to meet?" or "Would you prefer to discuss this in person during office hours or is an e-mail sufficient?"
- Give the instructor professional courtesy with a 24-hour window to allow them to respond.
- If you do not hear back from the instructor prior to the next class period, stay after class to let them know you e-mailed earlier and ask if they have a moment to chat; if they do, introduce yourself and let them know your concerns and follow up with an e-mail thanking them for their time and outlining the solutions that you agreed upon together. That will help both you and the instructor recall the conversation if more clarification is needed later in the semester. If you do not hear from the instructor, you will need to send another e-mail reminding them that you spoke to them after class and resend your concerns. You will need to do that in the same strand of e-mails on the day of your "after-class contact."
- Give the instructor professional courtesy (24 hours), but if you do not hear back, re-email and copy the Primary Academic Contact for dual enrollment. See the contact information below. You will want to outline in that e-mail the number of times that you have reached out to communicate both by e-mail and in-person. If you have academic concerns, you will need to outline your visits to the tutoring center and other resources used showing your effort. If the issue is related to technology, produce the time-stamped service ticket that our IT Help Desk sends when you reach out for service support. This can be critical if you have not been able to turn in an assignment due to connectivity.
- During this time, continue to work hard academically and continue to seek college resources that will assist with the hardships you face. You must do your part to minimize any communication or academic issues. Take responsibility for your college experience.
- If you do not feel that a resolution is possible (that is VERY, VERY RARE in most cases) you may need to withdraw from the course. Remember, however, that you have 2/3 of the way into the semester to change the trajectory of academic success. USE YOUR TOOLS and be thorough with how you communicate your needs and how you use your resources.

#### Parent Communication -Family Education Rights and Privacy Act (FERPA)

The Family Educational Rights and Privacy Act of 1974, commonly known as FERPA, is a federal law that protects the privacy of student education records. For students in K-12 who are under the age of 18, parents and guardians may view their student's grades or progress at any time. However, for college students, grades, records, and information are protected by FERPA, which means only the student may access this information.

Because dual enrollment students are enrolled in courses that may affect their high school transcript and credits for graduation, TCL strongly recommends that our dual enrollment students complete the <u>Student Information Release</u>
<u>Authorization form</u>, which serves as a FERPA waiver forparents as well as allows TCL to share studentgrades, records, and information with the student's high school. This form is available on TCL's Student Record Forms web page.

### Success Tips -Online Courses

Online courses are a popular option for college course delivery and offer both advantages and challenges. To be a successful student in an online course, we encourage you to consider the following as you plan your semester of learning.

#### ☐ Orientation & Training

✓ Take advantage of Blackboard orientation and training to help you learn how to navigate Blackboard, the learning platform where you will access and submit assignments, post to discussions, check your grades, and work in groups. #### ☐ Attend class!

✓ You must attend class by participating the first week of class or you will be administratively dropped for nonattendance. You should log in the first day of class. Some courses may have an assignment due on day one! Log in at <a href="https://www.tcl.edu/blackboard-gateway/">https://www.tcl.edu/blackboard-gateway/</a>.

#### ☐ Read the syllabus!

✓ The syllabus is the first material you should access in your online course. The syllabus will contain an overview of the course's content, a calendar featuring assignment due dates and material pacing, policies and procedures, your instructor's office location and contact information, and more! It is your responsibility to read the syllabus thoroughly and comprehend all course policies, procedures, and expectations.

#### ☐ Communication

✓ Keep the lines of communication open with your instructors by sending an email the first week of the course to introduce yourself or making an appointment to meet them in person, if possible. Be aware if your instructors have specific office hours at a campus location, by phone, or through Zoom. The moment that you feel you need assistance, may miss a deadline, or have any issue arise, be sure to communicate directly with your instructors as soon as possible.

#### ☐ Scheduling & Time Management

✓ One of the main benefits of online learning is the flexibility of scheduling. It is also one of the biggest challenges! Because you do not have a set time to meet in a classroom, it is your responsibility to set up your own schedule of learning. Create a routine by carving a special time to do all reading, studying and assignments for your online course and stick to it. Log in every day, even if it is just to check email messages and announcements. Be aware that Technical College of the Lowcountry instructors set their own schedules for due dates, so be sure to read the syllabus the first day of class to find out your due dates.

#### Submitting Assignments

✓ Always submit assignments on time, confirm that your submission uploaded, and that you submitted the correct item. Never assume that the submission uploaded successfully – always check. If you realize you submitted the wrong item, resubmit if possible. If an assignment is preset to accept only one submission, immediately email your instructor the correct item and explain what happened. Do not wait until after the deadline, or your instructor will have every reason not to accept your assignment.

#### ☐ Technology Back-up

✓ Internet failure is not an acceptable excuse for missing deadlines. Have a backup plan in case your computer breaks, your Internet goes out, or you have a power outage. As a TCL student, you have access to campus computer labs. Also consider public libraries, your high school computer lab, friends, and family. Also, it is important to save copies of all of your assignments in the event they are lost during the submission process. Always back-up your assignments to a flash drive, cloud drive, or email to yourself so you have them as email attachments.

MOST IMPORTANT: SUBMIT EARLY! Waiting until the deadline hour is not worth the risk of losing your Internet service, having your computer crash, or missing a deadline by seconds!

#### **Dual Enrollment Students Are Responsible For the Following:**

- Checking their TCL student email and Blackboard accounts daily for updates. The Dual Enrollment office recommends checking both accounts at least twice per day.

- 3. Attending class sessions and completing all assignments on time. Students must attend class and complete assignments by their due dates in order to maintain passing grades, as well as stay enrolled in their courses (see Attendance Policies\* for more information).
- 4. Initiating and maintaining regular communication with their instructors and school counselors. This includes contacting their instructor via their TCL student email and Blackboard accounts, stopping by their counselor's office, etc.
- 5. Seeking help when struggling with classes. Students must contact their instructor about any difficulties to receive assistance and/or develop an academic plan. After connecting with their instructor, students must notify their school counselor about their difficulties.
